## 1. Establish Quorum and Call to Order

Mr. Gentry convened the meeting at 4:01 p.m.

#### 2. Approval of Minutes

The minutes for November 20, 2018 and December 12, 2018 were reviewed.

**MOTION:** Mr. Atkinson motioned to approve the minutes and it was seconded by Mr. Mellen. The motion passed unanimously (6-0; Mr. Shreve absent).

#### 3. Financial Report

Mr. Oliver provided a financial report of transactions through December 31, 2018. He reported a total uncommitted fund balance of \$411,384.00.

#### 4. New Business

- a. Training Opportunity Mr. Newberry presented information on Virginia Industrial Development Authorities Institute (VIDA) to be held in late May.
- b. Director's Report Mr. Johnson provided the board with an update on EDA communication with the community. The Authority recently received "@albemarle.org" email address. There are two projects coming down the pipeline: Project Bengal and Project Browns. More details about these projects will be shared in the future. Mr. Johnson reviewed term limits of the Authority and noted that Don Long and David Shreve's terms end January 19, 2019. The Clerk's Office will be sending them information to reapply. Next month there will be a host of

presenters: Elizabeth Cromwell, Chamber of Commerce; Dr. Nikki Hastings, CvilleBioHub; Stephen Davis, Community Investment Collaborative.

c. Organizational Documents Dissussion – Mr. Johnson announced that a joint meeting of the Board of Supervisors and the EDA has been scheduled for June 18, 2019 from 4:00 to 6:00 pm to discuss the various documents that need updating such as the Bylaws, Rules of Procedure, and MOU.

Mr. DeLoria highlighted changes to the Rights and Responsibilities of the Economic Development Authority of Albemarle County under the Virginia Freedom of Information Act.

Mr. Gentry read a Resolution Approving Notice of Rights & Responsibilities Pusuant to Virginia's Freedom of Information Act. A roll call vote passed unanimously (6-0).

#### d. Certify Closed Session
