1. Establish Quorum and Call to Order

Mr. Gentry convened the meeting at 4:01 p.m.

2. Financial Report

Mr. Oliver provided a financial report of transactions through January 31, 2019. He reported a total uncommitted fund balance of \$310,460.27.

3. New Business

a. Director's Report – Mr. Johnson recognized Pace Lochte and Denise Hubbard from UVA's Economic Development Office and thanked them for their support.

Mr. Johnson presented and highlighted notable recommendations from the Teconomy Report for the GO Virginia Region 9: Piedmont Opportunity Corridor (Regional Entrepreneurial Assessment Project).

Mr. Johnson provided the Authority with other community updates, including the upcoming application deadlines for the Catalyst Accelerator Program. Mr. Johnson also requested the Authority authorize him and Mr. Gentry to engage with the Charlottesville Business Innovation Council (CBIC) about the chance to sponsor the upcoming Awards Gala at the Paramount Theater. There was no objection from the Authority.

- b. Guest Speakers The Authority received presentations from Elizabeth Cromwell with the Regional Chamber of Commerce, Dr. Nikki Hastings with CvilleBioHub, and Stephen Davis from the Community Investment Collaborative.
- c. Review of the Draft Capital Investment Grant Guidelines Mr. Johnson presented an overview of a proposed economic development tool to be considered at the joint BOS/EDA meeting in June. He explained the differences between two proposed classications of projects, Pinnacle Projects and Classic Projects. He presented different theoretical examples of each type of project and highlighted how the guidelines would apply to them. He outlined how tax increment financing assists projects that would not otherwise be able to go forward.

He discussed how this type of tool can allow Economic Development to positively impact the timing, design, as well as the scope and scale of a project.

Mr. Shreve pointed out that projects should not be considered solely on the basis of the public's ability to access cheaper financing; there should be other factors that are considered. Mr. Atkinson commented that this tool allows the public interest to participate in development in a way that it otherwise could not.

Mr. Walker and Mr. Ray discussed some of their experiences with public-private partnerships and how this type of tool can be helpful to facilitating desired projects.

Mr. Johnson will work to finalize document in preparation for the joint BOS/EDA meeting in June.

5. Other Matters – Mr. DeLoria recommended approval of an application for renewal of the Authority's Liability Insurance Policy. A motion was made by Mr. Ray to authorize Chairman Gentry to sign the application, it was seconded by Mr. Long.
