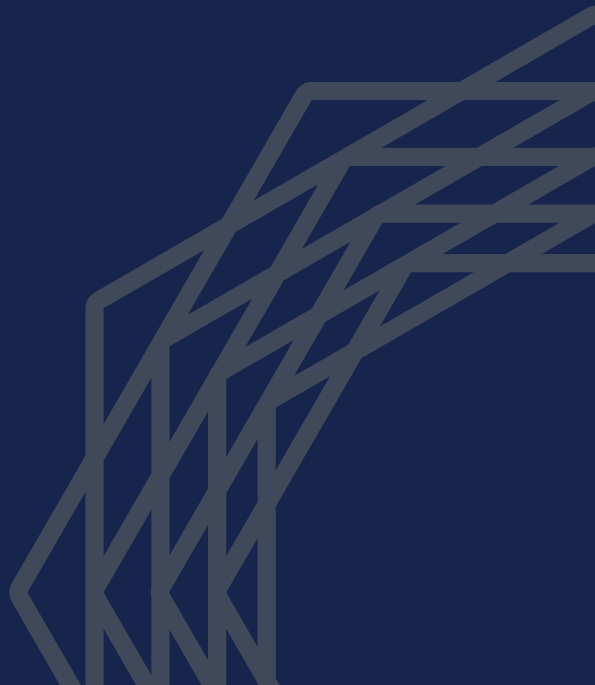

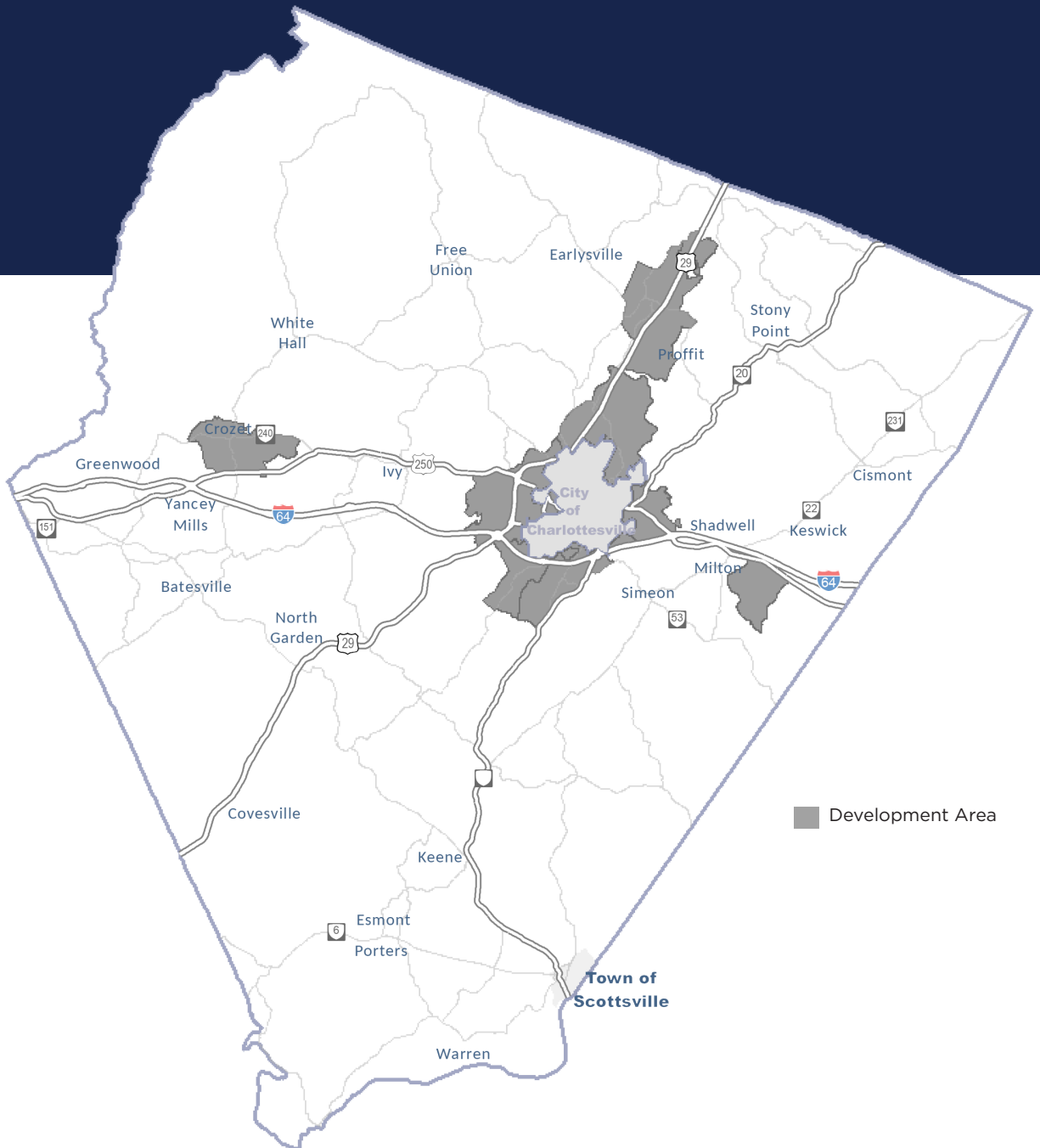


ENABLE

Featuring both rural and urban areas, Albemarle County is poised to accommodate a variety of business ventures and interests. The area is unique in its ability to grow while maintaining its charm and small-town feel.

Regional businesses benefit from a highly educated and skilled workforce, transportation infrastructure, and an unparalleled quality of life, making this an ideal community. There are five master-planned areas highlighted for development within Albemarle County—these areas have infrastructure in place to support business activity. In an already dynamic and vibrant local economy, this readiness provides a rare opportunity for business success.

WillowTree

WillowTree Inc. is a computer software company committed to helping clients realize the potential of rapidly evolving mobile technologies, from developing a mobile strategy to launching mobile products. WillowTree's clients range from medium and large businesses to Fortune 500s, and include Regal Cinemas, Wyndham Hotels, GE, AOL, PepsiCo, and the University of Virginia.

The County is investing in a redevelopment partnership because Albemarle recognizes the value of the significant private investment, job creation, and other direct and indirect benefits associated with WillowTree's relocation and expansion. Incentives include:

- \$500,000 in tax rebates
- \$200,000 to match the Virginia Jobs Investment Program
- \$160,000 for a transit partnership



This project will retain 200 existing jobs and create 200 net new jobs with an average salary of \$80,000.

Woolen Mills

“Albemarle County has been a consistent partner in the overall development of Woolen Mills and has always worked to find solutions to challenges instead of answering with a hard “no”. The County has honored the history of the site, helped with engaging the Rivanna River and trail system and looked to the future to unlock the potential this area of the County can offer the larger community.”

Woolen Mills will become the corporate campus for WillowTree, Inc., a highly valued employer with an anticipated private investment of \$12.3 million, a minimum of 200 projected net new jobs, and salaries far above the Albemarle County average. The Board of Supervisors partnered with the Commonwealth of Virginia, the Economic Development Authority, and Woolen Mills, LLC to redevelop the iconic historic site along the Rivanna River.

As part of this redevelopment project, the County will help provide public-serving infrastructure including, a trail connection linking the site to the existing Rivanna Trail across Moore’s Creek. A transit connection between the site and downtown Charlottesville will be established as part of the County’s commitment to alternative transportation.

Woolen Mills

The total employment impact on Albemarle County increases from 563 in 2019 to 1,152 in 2025. Corresponding impacts are \$93.3 million in 2019 to \$190 million in 2025.

Perrone Robotics

“Perrone Robotics is beyond excited to apply our technology to provide a zero-emission transit approach that will benefit businesses and neighbors – right here and right now in Albemarle County.”



Meet TONY, the autonomous technology that powers AVNU (Autonomous Vehicle, Neighborhood Use), the micro transit shuttle pilot program that launched this past summer as a result of an Albemarle County, JAUNT, and Perrone Robotics collaboration. The shuttle provided free rides throughout downtown Crozet. Onboard ambassadors served as tour guides and safety operators to provide a safe, informative experience to all riders. The project gathered feedback from users, operators, community members, and businesses. This project established groundwork for future autonomous transportation initiatives in the county and beyond.



Potter's Craft Cider

“We have enjoyed working with Albemarle County’s Economic Development Department on this project. We are very appreciative for the support of the county and the EDA as we have embarked on rehabilitating a historic stone church to create a new home for our cider company!”

Potter’s Craft Cider was seeking to expand its business footprint to meet customer demand for its cider products, but couldn’t at its existing site. The Board of Supervisors and the Economic Development Authority worked together to match a \$50,000 AFID grant from the Virginia Department of Agriculture and Consumer Services, granting \$100,000 to Potter’s Craft Cider to support their relocation/expansion in Albemarle. Potter’s Craft Cider and partners are committed to creating 12 full-time employees, generating over \$1.5 million in capital investment, and purchasing of over 2.5 million pounds of Virginia-grown apples. This project will rehabilitate Neve Hall, a historic structure, to serve as a tasting room and will establish a new 8,000 square-foot production facility.

Barnes Lumber

“Public Private Partnerships are one of the best ways the County can realize its economic and community development goals. I’m pleased Albemarle County is helping us and the Crozet community realize the long sought after vision for their downtown.”

The Barnes Lumber redevelopment project will transform a vacant industrial site in downtown Crozet, with a public plaza, commercial and retail space, a hotel, and approximately 52 residential units. Albemarle County entered into a Public-Private Partnership with Crozet New Town Associates to redevelop the Barnes Lumber property. The agreement included a \$1.6 million County contribution for tax financing and an additional \$1.6 million for a public plaza. The developer will provide \$2 million cash to match \$2.3 million from VDOT to build a road network.
